USDA restricts seven PACA violators

The U.S. Department of Agriculture has imposed sanctions on seven produce businesses for failing to meet contractual obligations to the sellers of produce they purchased and for failing to pay reparation awards issued under the Perishable Agricultural Commodities Act. These sanctions include suspending the businesses' PACA licenses and barring the principal operators from engaging in PACA-licensed business or other activities without USDA approval.
