Market Minute: California avocados ready for promotional activity

California supplies about 90 percent of all U.S.-grown avocados, produced by roughly 3,000 growers. The season runs spring through early fall, with peak volume now through August. Of the 500-plus known avocado varieties, California commercially grows seven, with Hass representing 95 percent of the state's crop. The Hass variety was first discovered in the 1920s by mail carrier Rudolph Hass.
